### This investment may be right for you if:-

- You are a **retail investor with an advanced level of knowledge regarding the financial markets and financial instruments AND understand the specific factors including the risks highlighted in the literature provided to you AND you also have previous experience of investing in products like this one.**
- You are looking for **income paid Every two months**, linked to the performance of the **underlying assets (Dell Technologies Inc., Warner Bros Discovery Inc, Intel, Gilead Sciences, Nvidia Corp, Tesla)**
- You understand that on an **Every two months** basis, on any given observation date, **if the basket performance value is below the coupon barrier, there will be no coupon for this payment period.**
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the part of the notional amount.** The magnitude of a loss per annum is represented by risk coefficient. For instance, on a \$10,000 investment in a 3-year product, if the basket performance value is -90%, you would receive 85% of initial investment back (\$8,500) with the risk coefficient 5% p.a.
