- You are looking for **income paid Quarterly following the valuation date, linked to the performance of the underlying assets Tesla, Nvidia Corp, Uber Technologies.**
- You understand that on a **Quarterly** basis, on any given observation date, unconditionally you will receive the coupon payment.
