- You are looking for **income paid Semiannually following the valuation date, linked to the performance of the underlying assets Nvidia Corp, Gap, Inc., Mobileye Global Inc, Enterprise Products Partners L.P., Warner Bros Discovery Inc, Dell Technologies Inc..**
