### This investment may be right for you if:-

- You are a **retail investor with a good level of knowledge regarding the financial markets and financial instruments and understand the specific factors including the risks highlighted in the literature provided to you.**
- You are looking for **income paid Semiannually**, linked to the performance of the **underlying assets (Visa Inc., Mastercard)**
- You understand that on **Semiannually** basis, on any given observation date, unconditionally you will receive the coupon payment.
- **You are looking to risk your capital, and in the event of the product not performing as anticipated, you will receive the amount of the product of the Notional and the Protection Level rounding down to the nearest whole number within 5 Business Days from the Maturity Date.** For instance on a \$10,000 investment, if the Protection Level is 60%, you would receive 60% of their initial investment back (\$6,000).
- **You understand that on Semiannually basis on any given observation date if all underlying assets are at or above their Autocall Price, the product will redeem early, and return the initial capital to you, including coupons and other payments that may be due**
