# What is the Product?

English law governed over-the-counter (OTC) equity derivative transaction linked to the worst performing share among those set out below with 'memory coupon' features. ### Objective

The product is designed to provide a return in the form of (1) unconditional coupon payments and (2) a cash payment depending on the realization of the credit risk of the **reference entities** (as defined below). The timing and amount of these payments will depend on the performance of the underlying shares. The product has a fixed term and will terminate on the **maturity date** (as defined below), unless terminated early. If, at redemption valuation date or earlier, you receive the credit event notice regarding at least 1 of the reference entities, you will receive the part of notional based on the price of the reference bond and, consequently, *LOSE UP TO YOUR ENTIRE INVESTMENT*.

*Coupon*. If on any **event determination date** (as defined below) the worst performing share's current price *is at or above* Coupon Barrier Price N of its initial price you will, within two (2) business days following that event determination date, receive a **coupon** equal to coupon rate N on the amount of your investment calculated for the period starting from the immediately preceding event determination date or, in respect of the first coupon, **valuation date** (as defined below) plus any unpaid coupons at Coupon Rate N for the previous period(s) multiplied by Snowball Coefficient (if no coupon rates were paid on the previous periods). *Early termination following Credit Event Notice*. If a Credit Event Notice is served to you on or prior to a Scheduled Termination Date, within five (5) Business Days, you will receive the cash payment based on the price of the **Reference Obligation** (as defined below), of the Affected Reference Entity and the product will be terminated. This payment is calculated as the product of: (i) the Notional; (ii) the minimum between 1 and the ratio of the Exchange Rate of the Trade Date and Exchange Rate of the date of the Credit Event Notice; (iii) the Performance Ratio of the Reference Obligation of the Affected Reference Entity; (iv) the Fallback Coefficient.

*Termination on the maturity date.* If the product has not terminated early, within five (5) Business Days following the Maturity Date, you will receive the Notional.

**Potential adjustment events.** If during the lifetime of the product a split, consolidation or any other event having a diluting or concentrative effect on the theoretical value of the relevant underlying share occurs the terms of the product may be correspondingly adjusted and you will be duly notified of such adjustment.

**Extraordinary events.** If during the term of the product any extraordinary event (such as nationalization, insolvency or delisting) occurs in respect of an issuer of any underlying share, such share's current price in respect of any date for the purposes of the product shall be decreased by 30%. 
### Intended retail investor

# What are the risks and what could I get in return?

The Ultima Products HK Limited applies its own risk methodology to determine summary risk indicator as well as performance scenarios indicated in the product documentation (KID). The costs shown in the table above represent how much the expected costs of the product would affect your return, assuming the product performs in line with the moderate performance scenario. The total costs are composed of the **early termination cost** up to 35% of the amount you invest.

### How long should I hold it and can I take money earlier?

### Recommended holding period: 56 months

The product aims to provide you with the return described under "What is this product?" above. However, this only applies if the product is held to maturity. It is therefore recommended that the product is held until the maturity date.

You, however, have an option to terminate the product early. In case you do so you will, within 5 (five) business days upon the proposed early termination date receive the **early termination amount** equal to 65% of the Notional multiplied by the lesser of (a) one; or (b) the ratio between the Worst Performing Share's Current Price as of Early Termination Valuation Date and 100% of its initial value. The The Ultima Products HK Limited may at its own discretion increase the Early Termination Amount.
