The manufacturer designed this product for a theoretical investor and suggests you liaise with the distributor to ascertain if you fit the criteria of its intended target market. You are aware that the underlying asset can include an Exchange Traded Funds/ Exchange Traded Trusts (ETF/ETT) with exposure to Crypto Tokens. Since the underlying assets are extremely volatile these ETF/ETT products are considered as high risk, the value of which can fall as quickly as it can rise. These products are complex and the associated risks may be hard to understand. You may lose, all or part, of their investment. Consequently, investing in and holding these products is not comparable to investing in traditional investments.
