You are aware that the underlying asset can include an Exchange Traded Funds/ Exchange Traded Trusts (ETF/ETT) with exposure to Crypto Tokens. Since the underlying assets are extremely volatile, these ETF/ETT products are considered as high risk, the value of which can fall as quickly as it can rise.
