USD dynamic coupon Phoenix Autocallable EDT linked to the worst of PG US, WMT US, MA US, V US and MCD US due 13.05.2028

Since the underlying assets are extremely volatile, these ETF/ETT products are considered as high risk, the value of which can fall as quickly as it can rise.
